Introduction

This release guide describes the optional Banner Finance 8.10.1 release.

This release provides changes to several database packages that are needed to support a new product offering, the Banner Finance Self-Service Purchase Requisition 9.0. Although this is an optional release for Banner Finance users, it is a pre-requisite requirement for using Banner Finance Self-Service Purchase Requisition 9.0.

NOTE: Banner Finance 8.10.1 is an optional release and does not contain content from any of the previously posted Banner Finance patches.

System requirements

The following minimum releases must be installed before upgrading to Banner Finance Optional Release 8.10.1.

- Banner General 8.7
- Banner Position Control 8.4
- Banner Accounts Receivable 8.3
- Banner Finance 8.10

Support for Purchase Requisition 9.0

This sections details the changes this release introduces to support Purchase Requisition 9.0.

NOTE: This release addresses CR-000132140.

Before this Banner Finance 8.10.1 release, the requisition related packages were used exclusively by the eProcurement messaging integration, between a third party eCommerce application and Banner, by the Ellucian Integration for eProcurement (IFEP) middleware. Database packages can now be used by Banner Finance Self-Service Purchase Requisition 9.0 with the changes contained in this optional release 8.10.1.

The usage of these packages within eProcurement messaging integration has not changed.

Modified packages

The following packages have been modified to enable Banner Finance Self-Service Purchase Requisition 9.0:

- FPKREQN (fpkreqn.sql)
- FPKREQN (fpkreq1.sql)
- FB_REQUISITION (fpkb_reqn0.sql)
- FB_REQUISITION (fpkb_reqn1.sql)

The FGKABAL (fgkaba1.sql) package has been modified to revise only the information messages text displayed during budget checking.
